Overview of Youth Recreation Camp Licensing Program

The New Hampshire Department of Environmental Services licenses youth recreation camps. The licensing program does not evaluate the camp curriculum, but does address a broad range of health and safety issues. In 2019, there were approximately 155 licensed camps. A list of licensed camps is available online at www.des.nh.gov or by calling (603) 271-2542.

Statutes:

The statutes pertaining to youth recreation camps are RSA 485-A:23, 24, 25 and 25a. These statutes can be found online at [NH Statutes Chapter 485A](#).

Rules:

The rules pertaining to youth recreation camps are Env-Wq 900 (dated 2019). These rules can be found on the [NHDES rules](#) web page.

Definition of a Youth Recreation Camp:

A youth recreation camp is a program that operates for at least 10 days per license year for the purpose of providing recreational opportunities, or a combination of recreation and instruction, to 10 or more youth per day, at a place which is continuously or periodically used for such purposes. The term includes residence camps and seasonal and year-round day camps.

Duration and Cost of the License:

The licensing period is annually from January 1 through December 31. The camp licensing fee is \$200 per camp, per year.

The Camp Licensing Program:

New camps must submit an application and have their facility inspected prior to receiving a license. Once the new camp is in operation a second inspection is made during the season to evaluate operational compliance. Annual inspections are conducted for all licensed camps.
