As of 2014, 46 water bodies in New Hampshire are polluted with chloride with more than 50% of the salt coming from private roads and parking lots. Burning of Demolition Debris Prohibited

NHDES wishes to remind local fire departments that the burning of any material remaining after the demolition of a residence or other structure is strictly prohibited by law, and has been prohibited since 2008. The only material allowed to be burned is brush generated on-site, with branches less than 5 inches in diameter. NHDES still receives complaints about illegal burns of demolition material in various locations across the state, including a recent instance in Bath.
