Thank you for the New Hampshire Coastal Program's (NHCP) October 20, 2008, request that changes to the NHCP federal consistency guide, public participation procedures, and list of federal assistance activities subject to federal consistency review be incorporated into the New Hampshire Coastal Program as routine program changes (RPCs), pursuant to Coastal Zone Management Act (CZMA) regulations at 15 C.F.R. part 923, subpart H, and Office of Ocean and Coastal Resource Management (OCRM) Program Change Guidance (July 1996). OCRM received the request on October 20, 2008, and OCRM's decision deadline was extended until January 16, 2009.
