NHDES Response to COVID-19

The coronavirus pandemic has cause many of us to do business differently. NHDES has set up a COVID-19 Response webpage as a clearinghouse for information related to any changes in NHDES program activity. #OneThing4Earth Video Challenge

NHDES has launched the #OneThing4Earth Video Challenge to help recognize the 50th Anniversary of Earth Day, which will be April 22, 2020. Wetlands Permitting Public Information Notice

Due to COVID-19 the citizens of New Hampshire, state agencies, and cities and towns are taking additional safety measures to protect our employees and customers. Because of the extra precautions to meet the CDC guidelines and the Governor's order, Towns and cities have closed their offices to the general public.

Many of our wetland application processes start with a town clerk signature (RSA 482-A:3, I(1)). In particular, the streamlined Wetland Permit by Notification and expedited permit application processes require conservation commission waiver of signatures to meet RSA 482-A: 11, III(a).

Accordingly, NHDES will accept emails from town and city clerks, conservation commissions, Local River Management Advisory Committees (LACs), and Rivers Councils to serve as records of receipt and/or waiver of intervention for wetland applications in lieu of wet signatures during this declared Coronavirus emergency. To ensure these town/city electronic authorizations connect to the right NHDES application, please include the applicant name, land owner name, location address, and project description to DES.WetlandsTownConn@des.nh.gov with subject line "Town Connect."

Handling of Solid Waste with Potential or Known COVID-19 Contamination

NHDES's Solid Waste Management Bureau has posted a NOTICE about the handling of solid waste with potential or known COVID-19 contamination. The Bureau is asking that if changes in facility operation due to the health emergency have been made, email those changes to solidwasteinfo@des.nh.gov. Starting on Monday, March 30, staff from the Bureau will be touching base with each solid waste facility. Each facility will have its own point of contact within the SWMB to discuss concerns regarding operations and solid waste management at the facility.

Homeowners' Handling of Waste with Potential or Known COVID-19 Contamination

Solid waste facilities across the state are making temporary changes to their operations, including temporarily changing operating hours and ceasing acceptance of recyclables, bulky waste items, or construction and demolition debris. Please check with your municipality regarding the current waste disposal options in your community. Further, NHDES reminds homeowners that: It is against the law to openly burn solid waste – burning solid waste can harm your health and the environment. Batteries, especially lithium ion batteries, can and do cause fires at solid waste facilities. Do not place lithium ion batteries in the regular trash. Please see NHDES' <u>Best Management Practices</u> and <u>SWOT Training Module</u> on batteries.

Solid waste operators are on the front lines of managing the waste we all generate and should be protected during this time. You can help by ensuring your waste is properly secured in closed trash bags. NHDES has posted a <u>notice</u> regarding the handling of waste with potential or known COVID-19 contaminated that has links to additional waste handling information. Notice to Solid Waste Facility Owners & Permittees -2019 Annual Facility Report Forms

The 2019 Annual Facility Report (AFR) forms, used for reporting required information regarding the operation of your solid waste facility (active or inactive) are available on our <u>Solid Waste webpages</u>. Please make sure you choose the correct form for your facility. These reports are due each year from all active solid waste facilities and the majority of the inactive landfills.
