Dear Mr. Gay:

The New Hampshire Department of Environmental Services, Air Resources Division (NHDES) is reviewing the application filed June 29, 2023, for the facility referenced above. NHDES has determined that additional information is required to deem the application complete, as described below. In accordance with the New Hampshire Code of Administrative Rules Env-A 607.06(a), *Temporary Permit Application Deficiencies*, a written response to this request is required within 30 days of this notification.

The following is the list of matters NHDES requests that Granite State Landfill address:

1. In accordance with Env-A 1703.01(a), Form ARD-1, *General Facility Information*, page 6 of the ARD-1 form, #17 Certification box must be checked. This indicates to NHDES that the applicant has right, title, or interest in the property, is authorized to submit the application on behalf of Granite State Landfill and certifies the accuracy of the information contained in the application. Please resubmit page 6 of the ARD-1 form by mail, as we require an original signature pursuant to Env-A 1703.01(a).
2. In accordance with Env-A 606.04(b), *Responsibility for Conducting Air Pollution Dispersion Modeling Impact Analysis*, the applicant must submit a report summarizing results of the air pollution dispersion modeling impact analysis and all data files necessary to verify the results. Please submit the additional documentation for the air pollution dispersion modeling impact analysis. 3. In accordance with Env-A 621.07, *Public Access to Information*, the applicant must submit two copies of the permit application. Env-A 621.07 requires that NHDES transmit a copy of an application for an air permit to the municipality in which the facility is or is proposed to be located. Please submit an additional copy of the application, including two copies of (1) and (2) above.
